## Water Treatment Operator

(40 Hours per week) Full-Time

The City of North Battleford has a full-time Water Treatment Plant Operator position available in the Operations Department. Roles and responsibilities include: Operating both Level 3 Surface WTP and Level 2 Groundwater WTP using SCADA and manual controls. Follow Emergency Response, Contingency Plans, or SOPs for reporting and correcting the production of any water that does not meet standards for turbidity, particle count levels, chlorine disinfection and/or UV irradiation. Start-up, shut down, and making periodical operation checks of plant equipment such as pumping systems, chemical feeders, auxiliary equipment, measuring and control systems. Perform preventive maintenance, confined space cleaning of SCU, operating adjustments, cleaning and painting. Perform corrective maintenance on plant equipment, for example chemical feed pumps, chlorine gas equipment, online analyzers, UV and other units. The principal function of this role is the production, storage and distribution of safe clean potable water to the residents of the City of North Battleford.

- Successful completion of Grade 12 or GED equivalent
- Post-secondary education in water, wastewater, engineering, science, and/ or related field is required. Relevant trades certification as defined by the Operator Certification Board will also be considered as acceptable secondary education.
